

This documentation posted is a Deposition taken by my first attorney Michael F Hornung, Prosecutor Dineen Baker and the alleged victim Michele Newland whom placed a HIT out on my by a motorcycle gang.

My life again has recently been threatened by this same man and associates. In this deposition Michele Newland was asked on 4 different occasions whether she knew anything about it. The deposition was completely unnecessary and they were just ACTING like they were going through the trial process.

Every word out of Newlands mouth was a lie. She should have been arrested in this deposition by the Prosecutor, but the State Attorneys Office, was covering up an intention bad arrest.

Page 28 line 17 Newland was asked by Hornung about myself being threatened. She said "NO"

Page 40 starting at line 18 going to page 41 Hornung asked her again and was going to bring up the fact he was a BIKER GANG MEMBER, but then he backs down. She again lies about the situation.

Page 41 Hornung asked Newland about a FRED TURNER. Newland attacked him, one night drunk. Because Fred Turner stuck up for me the night the biker gang attempted to kill me, in 2004 after my arrest reporting this threat that was valid.

Michael F Hornung brings up and ORDER DENYING AN ISSUANCE TO SHOW CAUSE, "for the record" as he states. The deposition was just a big ploy, and an act in hopes I would plea out.

Hornung was going to represent me, but was backed down by the SAO because Judge Thomas S Reese involve himself in this cover up. This deposition is completely golden to me, because it proves why I walked into

the Cape Coral Police Departement on 5-28-04 and was maliciously arrested.

Newland was asked if she ever contacted me on this injunction. Her answer was "No". But I have phone records and witnesses to prove she was coming over to my home and trying to reconcile.

The Government knows I can prove perjury to obtain an injunction so they needed to try and bury me, in every fashion. I have a copy of the CD, in which I was threatened and gave one to Hornung. The SAO dont have thiers because they would have had to charge Newland and this "OUTLAW"

11 Q. Who was the attorney that you hired to help

13 A. Marcy Shaw.

14 Q. Okay. And when you say he filed a motion to
15 get the restraining order dropped, that would be Mr.
16 Goodyear?

17 A. Yes, sir.

18 Q. So just going back to this document -- and,
19 for the record, it's a document dated April 6, 2004,
20 signed by Judge Winesett and it's an order to show
21 cause and it's an order denying issuance of an order
22 to show cause and it was filed here in Lee County
23 Circuit Court.
